#### Terms and Conditions

1. Please note that Elite Dance Project fees are payable by Cash or Bank Transfer
2. The student is enrolled until we receive cancellation of their classes in writing, then the termination will be taken as of the next term.
3. Elite Dance Project dance year is divided into four terms (terms may differ in duration)
4. Fees are charged each term (not by the week) and **payable in advance** for the full term.
5. Before the start of each term Elite Dance Project will issue an invoice via email/portal for fees due.
6. Fees are due and payable by the date of the invoice.
7. Fees remaining unpaid after 5 days after the due date of an invoice will attract an administration charge of \$20 to cover the cost of following up invoice for payment.
8. Students will not be able to return to class if fees remain unpaid, resulting in possible legal action for fees owed.
9. Elite Dance Project reserves the right to refuse admission to any student whose fees remain unpaid.
10. For any missed class, Elite Dance Project has a NO REFUND POLICY.
11. Dance is a physical activity, please note a degree of physical contact with the instructor and student may be required for either demonstration or correction of movement/s.
12. Dancing is a strenuous activity from which injuries could arise, Elite Dance Project and instructors are NOT LIABLE for personal injuries, loss of, or damage to personal property. I understand the importance of myself and my child following the instructions and rules set by the instructors.
13. I/we agree that Elite Dance Project can publish/use photos/videos of our children for advertising or publicity purposes.
14. Any child not collected by a parent/guardian consistently for more than 5 minutes after a class will be charged a late pick up fee of \$10/15minutes after the end of the class time they are registered for.
